Author's Checklist for Manuscript Submission

Please consult the "Instruction to authors" and complete the following checklist so that your manuscript will conform to the style and usage of the *Journal of Traditional Medicines* before submission and enclose this sheet with the manuscript. You may reproduce this page.

Check in the bracket

GENERAL

1. Submit in duplicate (1 original and 2 copies) / copies of photographs should be the same quality as the originals.

TITLE PAGE

1. Indicate the type of the paper: Regular articles, Short Communication, Case Report, News Letter, Reviews and Letters.
2. Title: Avoid using the trade name of a drug / should not contain abbreviations except for very standard ones
3. Provide a running title of no more than 40 letters

SUMMARY PAGE

1. Limit abstract to 250 words.
2. Do not cite references in Summary by reference number.
3. Provide Keywords: 3 to 6 items / avoid vague or overly general terms

MAIN TEXT

1. Drug name: Use generic names; if a generic name has not yet been given, provide the full chemical name at the first mention.

FIGURE -- refer to current issues --

1. Supply Figs. of sufficient quality for direct printing
2. Symbols indicating statistical significance: the number of symbols used to indicate a particular probability (P value) should be consistent throughout the manuscript.
3. Type legends for Fig. on a separate sheet.
4. Color photograph: indicate desired final printing size / color reproduction is charged to authors.

TABLES --refer to current issues --

1. Type each Table on separate page; do not insert in the running text.

REFERENCES --refer to current issues --

1. List references in numerical order according to the first mention in the text.
2. Cite all authors: do not use "et al."
3. State "(Abstr. In English)" for a paper with text written in languages other than English but with English abstract
